DGIF received reports yesterday of significant bat activity and the discovery of dead bats on the Landscape in Skydusky Hollow, Bland County, Virginia. Specimens are being collected and sent to appropriate labs for verification of pathology. This is the area where Newberry-Bane Cave is located, which was discovered to be positive for WNS last April. It should be noted that a year ago at this time bats in Newberry-Bane showed no signs of WNS, which did not become evident until late April.

Please report any sightings of bats on the landscape this winter (day or night, alive or dead) to either me (Wil.Orndorff@dcr.virginia.gov) or Rick Reynolds of VA-DGIF (Rick.Reynolds@dgif.virginia.gov). Note that the later in the year, especially in newly affected caves, the more likely you are to observe anomalous behavior at WNS positive sites. Last year in Virginia, the entrance queuing behavior was only observed at Clover Hollow Cave, not in the other WNS positive Virginia Caves. Clover Hollow was also the only place where bats had been reported on the landscape in Virginia last year. Of course, please also report and photograph any anomalous bat behavior or signs of WNS you observe if you are caving. So far we have seen no evidence of further southern expansion of the WNS range this winter. Please keep observing the protocols for decontamination and regionalization of caving.

To anyone wishing to assist with White-Nose Syndrome monitoring:

This winter, the West Virginia Division of Natural Resources and U.S. Fish and Wildlife Service are looking to the caving community to help monitor the distribution of White-Nose Syndrome (WNS) in West Virginia by conducting entrance surveys at caves to look for unusual bat behavior. Bats affected by WNS often fly out of the caves during the day, and dead bats can sometimes be found on the ground. or on rock faces, buildings, etc. near the cave entrance. This behavior is most evident later in the winter, so we suggest surveys be done between February 13 and March 14. If you would be willing to conduct surveys, please complete and submit the attached data sheet for each survey.

We are asking people not to go into the caves, but to observe the cave entrance from the outside for at least 30 minutes. Stay far enough back from the entrance that your presence will not discourage bats from exiting the cave. Biologists in Pennsylvania have noted that activity at cave entrances is greatest on warm days, especially following a cold spell, so when your schedule permits, try to pick a warm day.

When possible, it would also be best to select caves known to have a good number of bats in the winter. If you can see into the cave a ways without going into the cave, check the entrance area before you leave the site and note the number of bats near the entrance and whether or not the bats appear to be active, show any signs of WNS, etc.

Please look for dead and dying bats on the ground near the cave entrance. Photographs of the bats would be good for documenting the situation, but, at this time, we are not asking for any of these bats to be collected. Please do not touch or handle any dead or dying bats.

Please complete the table at the bottom of the data sheet indicating the time spent (including travel time to get to the caves) and miles driven to conduct these surveys. The WVDNR will be able to use the time and miles to help match a federal White-Nose Syndrome grant the state received. The grant requires that 25% of the project costs come from non-federal sources, so we need to come up with a match in order to spend the federal monies. Volunteer time can be used as part of the match.

Because these surveys will not detect all affected caves, you should assume that all caves, and the soil outside the cave entrance, are potentially affected by WNS and clean and disinfect your footwear before wearing them to another cave entrance. One option we plan to explore is the use disposable footwear covers to keep boots from getting contaminated. The most recent decontamination protocols can be found at:

To maximize the number of sites visited, I would encourage people to coordinate within your grotto and between grottos if possible. However, there is no harm in visiting a site more than once during the season if two groups chose to monitor the same cave. It is probably more important to get out there and survey than to spend too much time coordinating and not getting surveys done. Most of you are probably aware that Hellhole in Pendleton County appears to be affected by WNS. The WVDNR will be monitoring this cave, so please focus your efforts on other caves.

If you suspect a site is affected by WNS, please report this information ASAP to craigstihler@wvdnr.gov rather than waiting until all surveys have been completed to turn in your forms. Please return forms for all the surveys that you complete to Craig at the address provided no later than March 31.

Note that it is not unusual to see an occasional bat flying on a warm day in the winter; these are usually red bats or big brown bats, so not every bat flying in winter is an indication of WNS. Many of these bats probably roost in buildings or other sites where temperatures are less stable

than in caves. However, if you see a number of bats flying and feel something is "just not right," please report those sightings.

Thank you in advance to all who plan to help in the 2010 survey.

Subject: [MAR-NSS] New WNS videos

There are two new WNS videos available of a major PA hibernacula unknown to anyone other than locals until they reported it to the state in January. One is "homemade" by me, and another professionally produced for a show called Pennsylvania Outdoor Life. The OL life is well worth the watch and is a good overview of what is going on; the "homemade" version is much

higher resolution. Below is the relevant section of a larger trip report.

Carbon County, PA: Tresckow Mine: Visited at 10 AM with temperatures in single digits. There was a constant stream of bats in and out of the mine, up to 3 at a time. Bats were on the ground around blowholes in the rubble and around small holes in the outcrop where warm air was emerging. I videotaped a bat crawling in the snow and a minute later it was frozen dead. Birds are starting to remove carcasses. At the base of one tree in front of the entrance there were at least 20 carcasses, dozens, if not hundreds scattered around the rocks. Bats that emerged seemed to fly around for a minute, crash to the ground, crawl around a bit, and die.

A 5.5 minute video of this visit is available here under the "Tresckow Mine" section. What I found interesting is that I visited the site about a week or more after the WNEP Outdoor Life crew and I did not see nearly the number of carcasses that is in the Outdoor Life segment (also now linked to the web page below). But there was more snow when the OL crew shot their segment. There was also significantly more bats flying in the OL segment. It seems as if you only have a small window of opportunity to witness obvious mortality going on. Maybe the cold had everything depressed. Maybe there are no bats left (I visited 8 other entrances this day and saw very little activity).

Following West Virginia's lead on this, Virginia's agency coalition (DGIF, DCR Natural Heritage, and US-FWS) will be issuing a request similar to that which went out from Craig Stihler of WV-DNR for help with cave entrance surveys for bat activity during late February and March.

We've been working on this off and on since last week, and we should have the paperwork ready to go out tomorrow or Monday.

Survey protocols will be essentially the same as those in WV, except the forms will go to a different person.

Thanks to all for your continued commitment to addressing the unfortunate and tragic situation of WNS. Volunteer support and thoughtful comments and suggestions continue to help shape and improve the way the caving and conservation communities are responding.

So far this year, all reports we have received in Virginia have been from areas and caves very close to sites that were documented with WNS last year. However, first year sites may only exhibit signs of WNS very late in the winter or in early spring, and I suspect that is when we'll see signs of at least some southern and western range expansion.

Thanks again to everyone. And special thanks to Craig Stihler and Barb Douglass for developing the formwork and protocols for the entrance surveys, and for letting us jump on board.

Maryland Cave Survey Is Back

This story really starts last year in March 2009. Jerry received an email from Billy Gibberson asking if he had seen Speleobooks' web page lately. Billy had noticed Emily was advertising a fresh supply of older, out of print cave books, and wanted him to know. Jerry did want to know, and thanked Billy for the tip.

After looking at the site, Jerry called Emily and told her he wanted two titles for sure, and three other titles to look at. Since the Virginia Area Region spring meet was coming, Mike Warner would bring these and other books to vend. One of the titles Jerry wanted for sure was a PSC newsletter with a sub-title, Maryland Caves Supplement (1974). It came as a pleasant surprise, that this had been Dennis Slifer's very own newsletter. Dennis Slifer and Richard Franz did their first Caves of Maryland book in 1971, and a re-print of the work showed up with some additions in 1976. Jerry happily bought the PSC newsletter not knowing what it contained. Carefully comparing the 1971 and 1976 versions, with the 1974 supplement, he discovered the supplemental material never did make the 1976 additions.

Jerry knew there were some Maryland cave lookers on the scene, and realized the need to have this material reproduced. After a call to Dennis Slifer for permission to reproduce 15 or 20 copies, the supplemental re-print took shape. The cover was designed to resemble the original Caves of Maryland book, except smaller. The 1974 re-print is five-and-a-half inches wide by eight-and-a-half inches high. With maps and descriptions, it is sixteen pages.

A little while after the work was finished; Jerry mailed a copy to Dennis. End of story, right?

During 2009, it was discovered there are many people looking to expand the Maryland Cave Survey. For example, Jerry was on a field trip with the Baltimore Grotto in April of 2009 and it was learned that Jim McConkey was collecting new cave data on three Maryland counties around Baltimore. In the Tri-State Grotto, younger members have been quietly ridge walking, digging and surveying in Washington County. Cory Hackley and Sean Wooten have been coordinating efforts throughout 2009 and earlier years. Over the last five years, Cory and company have uncovered as many as 70 karst features, sinks, digs and a handful of significant cave passages. And who knows how long Ryan Boyce from the Western Maryland Grotto has been collecting data. Ryan has just stepped forward offering his collection of findings in the form of a Google map with stick pins. Maryland is ripe with new information. And what ever happened to the old Maryland Cave Survey information?

In January of 2010, Jerry received a letter from Dennis in the mail with an offer to own the historical Maryland Cave Survey. The letter outlined quite a number of marked topo maps, original (and duplicate copies of) hand drawn cave maps, photographs, letters, newsletters, handwritten notes and so on. Jerry was thrilled, and arranged a trip to Virginia to meet Dennis in person. On short notice he called Cory and Sean to see if they wanted to meet Dennis and ask him questions. They dropped everything and lunged at the opportunity.

On January 29, 2010 the three took the day off, met Dennis for a 2.5 hour lunch, and participated in a lot of show-and-tell. To show, Jerry had library collections for Mt. Aetna Cave, Cumberland Bone Cave, Bushey Cavern and others. Cory brought actual excavated artifacts in a cigar box, plus documentation on

his recent finds in Washington County. Jerry also gave Dennis a copy of the history of Mt. Aetna Cave that included pictures of his trip inside. Dennis was kind enough to autograph copies of books. It was a great lunch and no one wanted it to end. The deal was consummated and grudgingly the three made their way home, but not before they stopped and field checked two karst features.

Dennis wanted to say something in his own words about why he selected Jerry to own the historical Maryland Cave survey. Here is what he said:

"Having stored too many boxes of stuff for too many decades, I decided last year it was time to divest myself of this ancient history. My interest in caving waned long ago, to be replaced with other pursuits. The first round of purging was my cave library, which went to Speleobooks as Jerry mentioned. That left my collection of archived Maryland Cave Survey material still gathering dust and mold after forty years. Jerry's initial contact with me about reprinting the supplement was courteous and professional. Several months later he sent me a copy. I liked the job he did on that, and appreciated that he followed up on it. It was obvious he had a keen interest in Maryland caves and their history, and I suspected he'd be a good steward of the archives I possessed. I offered the collection to him, and the rest, as they say, is history. I'm glad to see interest from him, Cory, Sean, and others in a revision to the Caves of Maryland. I've offered to assist in this: my original photos are available for use and I'd be glad to write a foreword or preface to whatever type of publication results. I'll even go underground again if you find something spectacular.

Mold!? Jerry looked thoroughly through all the material and didn't find any mold, sorry.

As exciting as this is, it is just the beginning of sorrows! There is going to be a lot of work coordinating ideas from at least four or more contributors. The talk is about printing a new book to include the new findings—yes this should be done. When Davies did the Caves of Maryland book in the 1950s, he published what he found. When Franz and Slifer did their book, they added their findings to Davies to make one complete book. Two other states did it differently, Tennessee and Virginia. Tennessee came out with the Barr book and later Matthews added a supplement. In Virginia it was Douglas with Holsinger adding a supplement. It was evident in Mathews and Holsingers work that only new caves were described. They only covered a previously mentioned cave if they were making corrections or adding a significant amount of new information. These questions and others will need to be answered in upcoming meetings.

So how come all this new information is streaming in and the old survey information just shows up? Perhaps it was just meant to be. Though not officially announced or organized, one contributor has expressed the Maryland Cave Survey is up and running. So reader, if you are interested in Maryland caves, stay tuned. Watch the email lists for time and place where some of these things can be discussed, and maybe you'll want to become a charter member of the Maryland Cave Survey, revisited.


